- Total revenue in the fund: \$4,918,412.
 - One time revenue from license conversion fees: \$3,143,267.
 - Ongoing revenue from cannabis sales and use tax: \$1,775,145.
- Update to the fund since October 2024: \$281,943 deposit in November 2024.
- Discussion of the allocation of funds for a grant program, already reflected in the budget.
 - Discussion of returning funds allocated for a grant program into the undesignated balance.
 - Discussion of the County budget process.
